Competition Overview: The Route 65 BBQ Rib Contest (“competition”) is a barbeque cooking contest being held by Route 65 Pub & Grub (“competition organizer”), on Sunday, October 11, 2020 at Route 65 Pub & Grub located at 18407 Hwy 65 NE East Bethel, Minnesota. The competition will feature only a pork rib category. Each team will be assigned up to a 10’ x 20’ BBQ site, all cooking must be done in this area. Only charcoal, wood, pellet, or chips may be used for cooking. Electric smokers are acceptable, but no propane. You must provide your own electric with a quiet generator. Electric accessories like rotating spits are allowed. Ask in advance if you have questions about legality.

Entry Fee & Contest Information: Team entry fee is \$125. Four (4) racks of ribs will be provided in the competition. Cooking may start AFTER the 7:00 A.M.

team meeting the day of the competition. Rib Rib entries will be at 2:00 pm on the day of the competition. A competitor may submit only one (1) entry to the judges. There are four (4) judges, so competitors will submit four (4) total pieces of rib meat, one to each judge. Competitors must provide their own coolers/ice for storage. Competitors will be given a 9” x 9” clamshell container go-container in which entries will be submitted to the judges. It will be numbered as part of the double-blind judging system. Each entry should include four separately identifiable rib pieces. Nothing but meat is allowed in the box. No garnish, no side of sauce, no other type of food. The box cannot be marked or put together in such a way that identifies the team. Ask if you are wondering whether what you are doing is acceptable. You must keep your cooking area clean and place all trash in the dumpster before leaving. A list of safe food handling practices will be provided, and you are expected to follow these practices.

Prizes: Categories include: Judged Competition, Peoples’ Choice and a combination of judged competition and peoples’ choice for Grand Champion and runner up. Prizes will be awarded for first, second, and third place in the Judged Competition and Peoples’ Choice categories. Prizes will be awarded for first and second place in the Grand Champion category. There will be a total of \$6,000+ in cash and prizes for contestants.

Grand Champion – \$500 for first place, \$250 for runner up

Peoples’ Choice - \$1,000 for first place, \$500 for runner up, \$125 for third place

Judged Competition - \$1,000 for first place, \$500 for runner up, \$125 for third place

Liability: Participant agrees that the Competition Organizer – Route 65 Pub & Grub – will in no case be responsible for any loss, damage, or injury regardless of how much loss, damage or injury is occurred and releases Route 65 Pub & Grub from any and all claims, suits, and/or judgements including the cost for defense of any occurrences.
